School assignments.

I have five schools to be the liaison to including Salisbury High including Sherwood Park Outreach (formerly Next Steps), Clover Bar Junior High, Brentwood, Wes Hosford, and Ecole Campbelltown.

On Thursday November 4, I had the privilege of visiting each of my schools and personally meeting the principal and admin team and receiving a tour of the school. Thank you each of you for the time that you took to show me around and briefly update me on the issues any issues with the facility grounds or programs.

October and November are very busy months for trustees with the election on October 18, the board organization meeting and swearing in on 28 October and a one day board orientation and planning on October 29th. November includes a caucus (planning, not public meeting on November 10 and the fall Alberta School Board Association meeting on November 15 and 16th.
